1. Background

To serve Peace Support Operations (PSOs) training tasks and requirements, MPSOTC conducts several Courses per year for personnel categories that include military, law enforcement, civil servants, and civilians. One of these courses is the “Security Management in Situational Prevention”, which is going to be conducted ONLINE from **7th to 18th November 2022**.

The maximum number of slots at the course is 50, however, the international students cannot exceed 30. Available slots will not be exceeding 3 per interesting nation, but in order to encourage the largest possible international participation, each nation may bid for reserve slots. The closing date for bids is on **26th of October 2022**.

2. Course Specification

a. Accreditation

The “Security Management in Situational Prevention” **e-Learning** Course is approved by the Hellenic National Defence General Staff and is also a “NATO Listed” Course, with the distinctive E-PRIME code “MPSOTC.8.4” and ETOC number: CTM-CT-35525.

b. Purpose and Aim

The overall purpose of the course is to provide students with a basic working Knowledge of security management skills and requirements.

This Course aims to:

- Familiarize Military/Law Enforcement personnel and Civilians (employees from Civil Protection authorities, internal/external affairs, public administration or private security sector) from different countries and professional background, with the aspect of critical personnel and installation security.
- Enhance the operational and planning capabilities of trainees, regarding

- Increase awareness regarding modern security risks and threats, including “hybrid war” threats.

- Introduce counter - terrorism, counter - asymmetric attacks & counter - criminality methods of protection by emphasizing in security management and situational prevention.

c. Objectives

Through general orientation, within two weeks theory, students will receive:

- An introduction to:
 - Security management regarding the latest evolutions of public and private sector security coordination.
 - Private security issues as elements of: counter - crime policy and national/international security.
 - The 5 models of a security supervisor.
- Familiarization with topics such as terrorism and counter – terrorism.
- Security planning process and conduct.
- Close Protection Team (CPT) procedures and techniques.
- Risk Management/Analysis process.
- Orientation on the nature of critical infrastructure in security planning.
- Basic principles of Security Personnel training.
- Familiarization with the aspect of health and safety in installations, as an overall task for the security officer.
- Realistic “on the spot” training by visiting high security risk installations.

d. Student Criteria

To be eligible to attend the “Security Management in Situational Prevention” Course, nominees must fulfill the following criteria:

- Military Personnel with a general military background experience from national duties, ranging from OR-7 (Staff Sergeant) to OF-5 (Colonel) rank.
- Law Enforcement Personnel of equivalent ranks.

- Civilians coming from private sector and employees of International/Non-Governmental Organizations, with relevant job description.
- Participants are equally welcomed from other levels of governance i.e. Ministries of Foreign Affairs, Defense, Environment and/or Internal Affairs as well.
- Language proficiency: Military non-native English-speaking Students must have the following minimum proficiency standards in English, as described in NATO STANAG 6001: **Listening Good (3), Speaking Fair (2), Reading Good (3) and Writing Fair (2).**
- For non-military personnel, same minimum language proficiency is needed, according to the relevant international standards for language competence.

e. Security Clearance

The course will be conducted at NATO/EU/PfP/MD/ICI **UNCLASSIFIED** level. **Security clearance is not required.**

f. Course Duration

From **7th to 18th November 2022** (10:00 – 14:30 Athens – local - EET daily).

g. Course Fees

Full course tuition fees cost is **300€ (Euros)** per person (total), unless it is otherwise regulated based on bilateral agreements (between Greece and the interested party).

After a candidate is selected for participation, the Course fees must be paid in full **NLT 28 October 2022** via bank transfer. A copy of the invoice will be mailed to the participant email which has been declared during the application procedure. The payments can be done to the following account:

3. Student Allocation Procedure

a. Student Joining Report

Student's Joining Report should be sent to MPSOTC **not later than the 26th of October 2022**. MPSOTC reserves the right to elaborate requests received later than the aforementioned date, if slots are available.

It is important that the invitation itself reaches out potential student(s) on time, since it contains needed information. MPSOTC will be able to provide a read ahead package with useful material before the Course starts, such as application form, official confirmation letter (of acceptance), Course curriculum, schedule, etc.

b. Point of Contact (POC)

A national point of contact (POC) should be mentioned in the application form, who authorizes the participant to attend the course. Skip this step if the application form is attached to an official letter from national MoD, MFA, NATO HQ, embassy etc.
